Nomination papers must be hand delivered to the Returning Officer, St Albans City & District Council, Electoral Services, 2nd Floor, Civic Centre, St. Peters Street, St Albans, Herts, AL1 3JE on any working day from Monday 25 March (excluding bank holidays), during normal office hours (8:45 am – 5:00 pm on Monday – Thursday, 8:45 am – 4:45 pm on Fridays) but no later than **4 pm on Wednesday 3 April 2019**.
2. Nomination papers may be obtained from the offices of the Returning Officer, St Albans City & District Council, Electoral Services, 2nd Floor, Civic Centre, St. Peters Street, St Albans, Herts, AL1 3JE during the times stated above.
3. If any election is contested the poll will take place on Thursday 2 May 2019.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **Friday 12 April 2019**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the address below by **5 pm on Monday 15 April 2019**.
6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at the address below by **5 pm on Wednesday 24 April 2019**.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the address below by 5 pm on Thursday 2 May 2019. The physical incapacity must have occurred after 5 pm on Wednesday 24 April 2019. To apply on the grounds of work/service the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday 24 April 2019.
