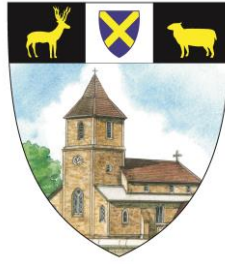

- The Green Man Public House has been listed as an asset of community value (ACV) at the Parish Council's request following Councillor Newton Davies's recommendation. The public house will remain on the ACV register for five years. The owners have eight weeks in which to appeal this decision.
